## **Roles and Responsibilities of the IPR Cell:**

- 1) To create awareness among students, faculty, and staff regarding intellectual property rights, including patents, copyrights, trademarks, and trade secrets.
- 2) To provide guidance and assistance to members of the college community in identifying and protecting their intellectual property.
- 3) To facilitate the process of filing patents, copyrights, and trademarks for inventions, research outcomes, and creative works developed within the college.

- 4) To liaise with external agencies, legal experts, and patent offices for the registration and protection of intellectual property.
- 5) To organize workshops, seminars, and training programs on intellectual property rights and related topics.
- 6) To establish collaboration with industry partners for technology transfer and commercialization of intellectual property.
- 7) To undertake any other responsibilities assigned by the college authorities related to intellectual property rights.

The committee will meet regularly (e.g., quarterly) to discuss ongoing activities and new developments.

The IPR Cell shall function as per the guidelines issued by the Government of India and AICTE for promoting IPR awareness and management in educational institutions.
